Data Collected

Cookies Used

Data is not sold to third parties nor used for purposes other than those described in this policy, unless specific consent has been obtained or required by law.

Transfers Outside Switzerland / EU

If certain service providers are located in countries that do not offer a level of data protection equivalent to Switzerland or the European Union, appropriate safeguards will be implemented (standard contractual clauses, internal rules, etc.), or the transfer will be based on your explicit consent.

5. Users' Rights
